NOTE : (i) The list of selected candidates published by the Commission in pursuance to this Notification shall remain in force for a minimum period of One year and a maximum period of three years provided that the list will not continue to be in force if a new Ranked List after the minimum period of one year is published. Candidates will be advised against 5% of vacancies reported during the currency of the Ranked list.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of Appointment	:	By Transfer from among the suitable qualified candidates from the low paid permanent employees in the Corporation in the cadre of Driver, Peon/Watchman and Attender.
6. Age Limit	:	There will be no upper age limit for recruitment by transfer.

7. Qualifications :
Degree in Commerce

NOTE:- (a) The candidates who secure not less than 40% marks in the competitive test are eligible to be included in the Ranked List for recruitment by transfer. Every 20th vacancy will be filled up from this list on the basis of merit. In the absence of candidates in the list, the vacancy will be filled up by direct recruitment.

(b) The rules of communal reservation contemplated in rules 14 to 17 of the Part II of Kerala state and Subordinate Service Rules 1958 are not applicable to appointment by transfer.

(c) The qualified low paid employees of the concern may apply in the prescribed application form or by Online facility provided in the Website of the Kerala Public Service Commission. The applicant should furnish a Certificate obtained from the Head of the Corporation showing the Service particulars in the form given as Annexure to this Notification as and when required by the Commission. Candidates should not enclose the certificate along with the application. Candidates who apply for recruitment BY Transfer should note clearly at the top of the application at side 'B' "For Appointment By Transfer" and darken the relevant bubble at side 'A' of the application. Applications without the heading mentioned above will be summarily rejected.
