Note:- (1) Applications submitted by candidates belonging to the communities other than that notified will be summarily rejected. No rejection memo will issued to these candidates.

(2) Separate Ranked List will be prepared for each district in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against all the N C A turns identified as unfilled during the currency of the Ranked List published for the post in the following districts.

(3) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS)No.154/71/PD, dated 27.5.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(Ms)No.4/61/PD, dated 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from Muslim community only).

6. Age Limit: 18-46 : Only candidates born between 2.1.1964 and 1.1.1992 (both dates included) are eligible to apply for this post.

Note:- (Including the relaxation as per para 2 (i) of General Conditions). For candidates regarding other age relaxation please see para 2 of the General Conditions except para 2(i).

7. Qualifications:

1. Pass in S.S.L.C or its equivalent.
2. Successful training for period of not less than three years in General Sick Nursing.
3. In the case of Women candidates successful training for not less than nine months in Midwifery from an institution recognized by the State Government and in the case of male candidates successful completion of short term course in one or the other of the Nursing subjects of Venerology, Urology, Psychiatry or Ophthalmology conducted in a major hospital.

Note:- Those who have undergone successful training for not less than six months in midwifery will also be eligible for appointment as Staff Nurse (female) subject to the rules of reservation rotation. Preference will be given to candidates who have undergone successful training for not less than nine months in midwifery for the purpose of Direct Recruitment to the post of Staff Nurse (Female).

4. Certificate of Registration with the Kerala Nurses and Midwifery Council as Nurse in the case of male candidates and Nurses and midwives in the case of female candidates.

Note:-(1) Those who have got themselves registered with other State/Central Nurse and Midwives Council could also apply. But they should get themselves registered with the Kerala Nurses and Midwives Council before taking up appointment under Kerala State Government.

(2) Physically handicapped candidates are not eligible to apply for the post.

8. Last date of application : 21.7.2010 Wednesday upto 5 p.m.

9. Mode of sending application :

The applications shall be submitted only through on-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of Kerala Public Service Commission viz. www.keralapsc.org No application fee is required. The barcode number in the application form from the Website shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age and community have to be produced as and when called for. Application which are submitted not in accordance with the instructions given in the website will be summarily rejected.
