Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary lists of Other Backward Classes, their register numbers will be deleted from the Short list without further notice, if they fail to produce the Non Creamy Layer Certificate

The candidates who have secured **58 (Fifty Eight)** marks and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of the Ranked List. Application for issue of copy of OMR Script will be considered only after the publication of Ranked List..

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 200/- by way of chalan in any of the Treasuries in the State (head of Account0051-PSC-800-other receipts-99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) www.keralapsc.org. along with the original chalan should be submitted to the District Officer, KPSC District Office, Palakkad within one month from the date of publication of the Ranked List. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be intimated against those who do so.
