The candidates who have secured **53 (Fifty Three)** marks and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the candidates included in the Supplementary Lists.

The candidates belonging to Backward Communities included in the Short List, who are required to produce Non Creamy Layer Certificate as per G.O.(P) No.46/07/SC/STDD Dated 25/08/2007 shall produce the same along with the other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. As regards, such candidates in the Supplementary Lists of Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

The date, time and place of interview will be intimated in due course.

Re-checking of answer scripts will not be allowed before publishing the Ranked List.
